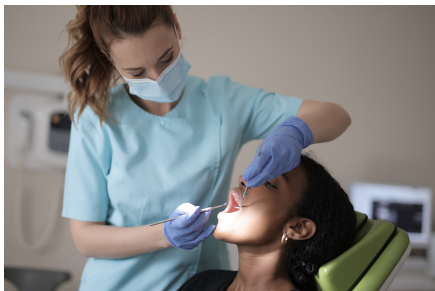

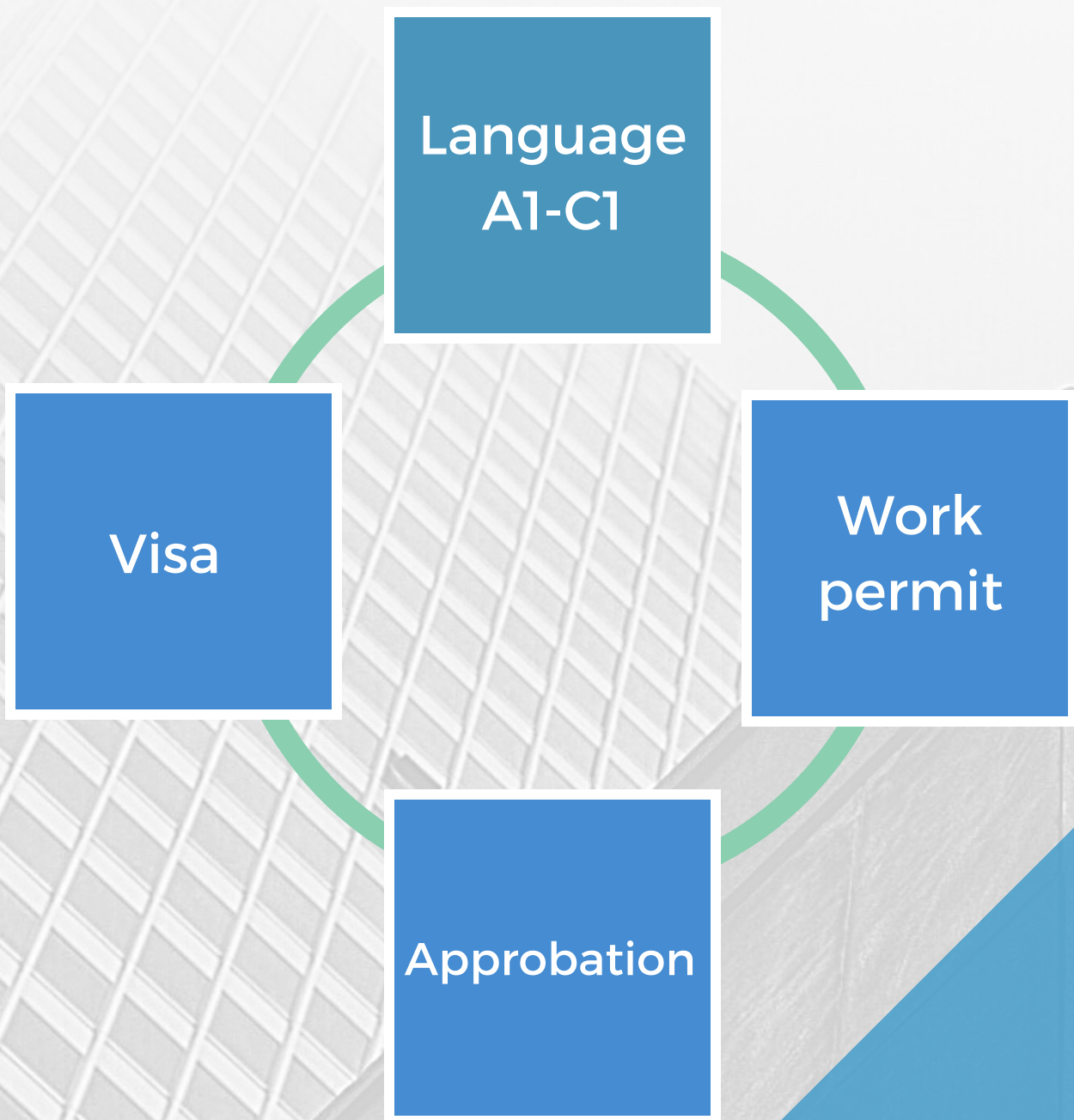

WHY GERMANY?

- Germany has one of the best healthcare systems in the world
 - Use of the very latest therapies and medical equipment
 - Germany opens up new possibilities for medical care, as X-ray images and medical reports
 - Annual income of 260 billion Euros
 - 4.3 million employees
- 58.168 non-German Doctors working in Germany

REQUIREMENTS TO WORK IN GERMANY IN THE MEDICAL FIELD



Language Requirements

All applicants with 6 years of general or specialized medicine from outside Germany need to make approbation in Germany.

Approbation Requirements:

- Five courses in German: A1, A2, B1, B2, and C1
- Each course consists of 100 – 200 hours.
- Finishing A1 – B1
- Finishing B2 – C1 in Germany.
- Finishing B2-Medizin – C1-Medizin in Germany.
- C1 exam at the medical chamber.

APPROBATION

All applicants with medical degrees from outside Germany, need to make approbation in Germany. There are two kinds of approbation:

One to one approbation:

- The education from most EU Countries will be recognized as being equivalent to German medical education and the applicant acquires the approbation.
- Approbation equivalent to the German medical education system:
- The education from non-EU countries will be tested according to the equivalency. If your education is not equivalent to the German system then you get a job search permit for two years. In these 2 years, you have to make the Gleichwertigkeitsprüfung (equivalency exams for approbation).

GLEICHWERTIGKEITSPRÜFUNG

In the equivalency check the competent authority compares your degree with the German medical degree and checks whether there are any significant differences.

The exam relates to the content and duration of the study

The test relates to the subjects medical Practice and Special Areas of Law for medicine as well as to one of the subjects in which the competent authority has identified significant differences.

These classes are offered by the medical chambers. In the equivalency check, the competent authority compares your degree with the German medical degree and checks whether there are any significant differences.

VISA REQUIREMENT

Recognition of qualification:

- Bescheid: Letter from approbation office about differences in recognition and needed process
- Motivation letter
- CV
- Medicine certificate
- Registration for (B2) and C1 in Germany
- Job permit (optional)
- Language min. B1 /B2
- Financial Proof
